Systematic: Uses a fully quantitative approach to reduce the impacts of human bias in stock selection and portfolio design.



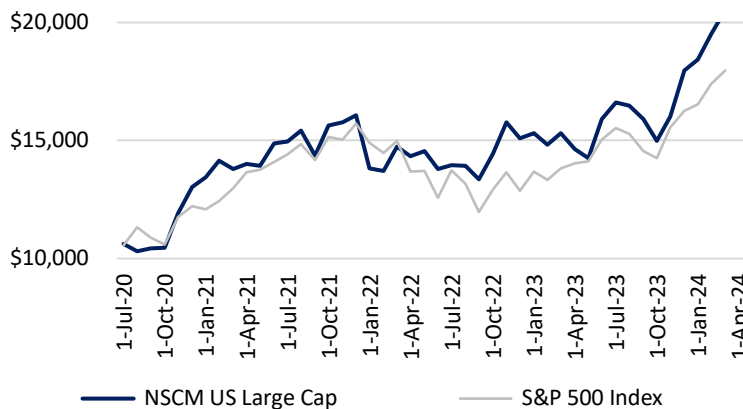
Dynamic: Aims to invest in the most attractive parts of the market, dynamically shifting between sectors and industries as the market environment changes.

STRATEGY OBJECTIVE & PROCESS

Objective: Our US Large Cap strategy seeks to outperform the S&P 500 Index over a full business cycle using our proprietary, momentum-based quantitative portfolio construction framework. The strategy is agnostic about stock valuations and aims to generate outperformance over the long-run. As a result, the strategy has a high tracking error relative to the S&P 500 Index.
